I certify that \_\_\_\_\_ is in good health and capable of full participation in the activities of Nature and Adventure Summer Camp at Riverbend Park sponsored by Canoe Outfitters of Florida, Inc.

I realize that there are certain inherent risks and dangers involved in out-of-door activities. These may include, but not be limited to, physical exertion, the hazards associated with forest, lake and wetland terrain, the forces of nature, contact with water, plants, insects, animal life and travel by vehicle, boat, canoe, kayak, bicycle and any type of labor or practices associated with summer camp life made available by CANOE OUTFITTERS OF FLORIDA, INC. (COF). I represent to COF that the minor child for whom I am responsible, is in good health and physically able to safely participate in out-of-door activities. I realize and agree to inform this minor child, that participation in these activities may result in property loss, delay, illness, injury, paralysis or death due to the foregoing dangers, the negligence of others, forces of nature, or other causes known or unknown. I specifically realize that the dangers increase significantly if this minor child enters the water. I am also aware that medical services may not be readily available or accessible during part or all of these activities. By this minor child's participation in these activities, I hereby knowingly and expressly assume all risks arising out of them.

As a supervisor of a minor child, I make this agreement individually on behalf of this minor child, to induce COF to allow this minor child to participate in the summer camp activities.

I also, on behalf of myself, my personal representative and my heirs hereby covenant not to sue and I agree to release, hold harmless, and indemnify COF and its agents, officers, employees or successors from any and all contract or negligence claims and suits for bodily injury, property damage, **wrongful DEATH**, loss of services or otherwise which may arise out of this minor child's participation in the activities of summer camp life made available by Canoe Outfitters of Florida, Inc.

This contract shall be governed by and constructed in accordance with the Laws of the State of Florida, and the parties agree that the venue and jurisdiction for any action or proceeding arising out of this summer camp agreement shall be in Palm Beach County, Florida. This contract shall be construed without regards to any presumption or rule requiring construction against the party causing the rental contract to be drafted.
